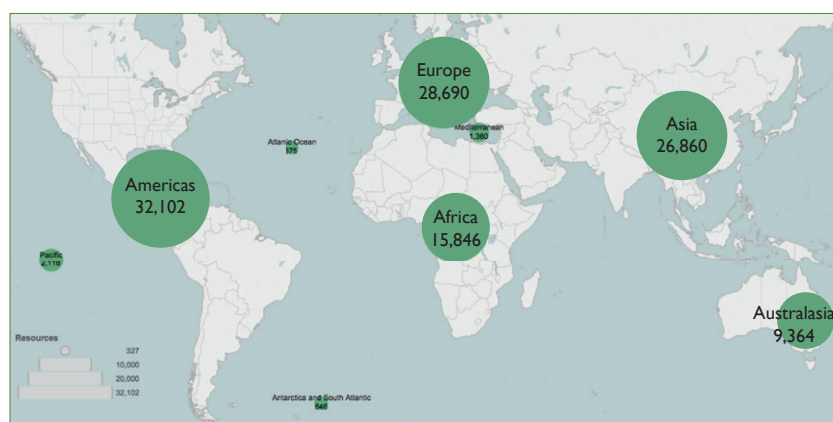

Global reach

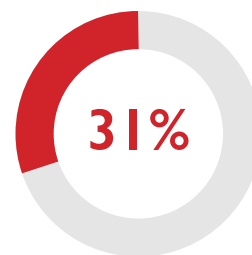

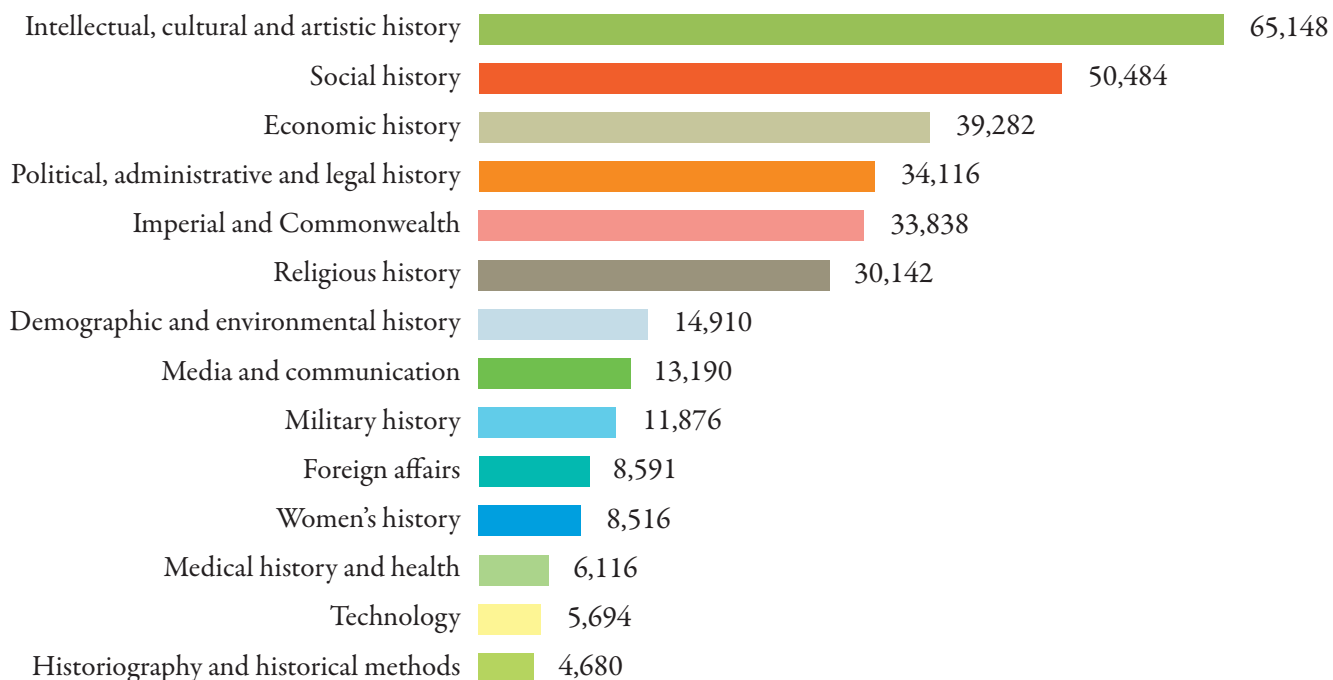

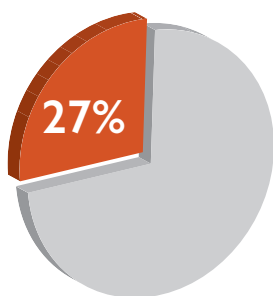

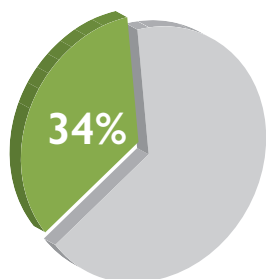


Number of BBIH records per subject area for the period 1688-1815

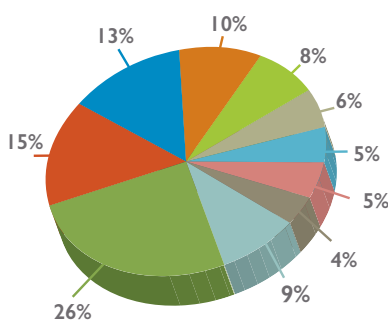

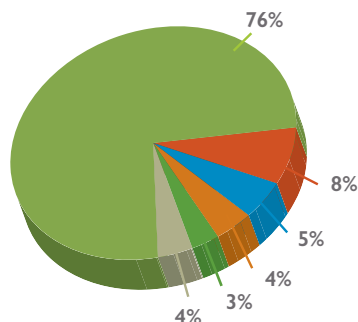

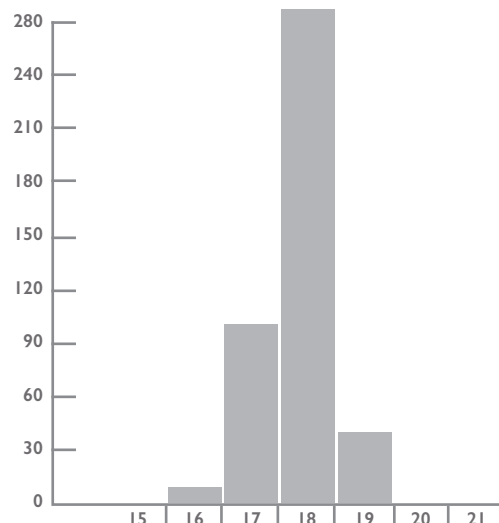
