## **SENIOR FELLOWSHIPS 2022-23 INFORMATION FOR APPLICANTS**

### **ELIGIBILITY**

Senior Fellowships will be awarded to those candidates with a distinguished record of achievement in historical research or who have made a significant contribution and impact in historical studies. Preference may be given to those currently engaged in work which is associated with one of the Institute's research centres, or which makes use of the IHR's resources.

We particularly welcome applications from those whose work will help the IHR to pursue its strategy aims in some of the following ways:

- supporting and promoting 'Inclusive Histories' across the IHR and beyond;
- assisting in the intellectual and professional development of digital history across the IHR and beyond;
- assisting in the intellectual development of the history of people, place and community across the IHR and beyond;
- assisting in the development of the IHR Wohl Library and the exploitation of its holdings;
- developing the IHR's contribution to applied historical research and connections between history, policy formation and wider applications of historical understanding;
- guiding especially early career historians in professional development beyond academia, including public history, museums, archives, conservation and publishing.

It is expected that Senior Fellows will make two or more of the following contributions to two or more of the following: attend conferences, be ambassadors for the Institute, encourage and foster the work of Junior Fellows and other early-in-career researchers, give seminar papers, carry out research training. Fellows are *not* required to be based in London or the UK.

### **WHAT WE OFFER**

Senior Fellowships are awarded for three years in the first instance, but are assessed by the IHR's independent Advisory Council on an annual basis during this three year period, with approval required to continue the affiliation into the next year. Requests for renewal beyond the three year appointment will be considered and awarded where appropriate on an annual

basis.

All Senior Fellows are invited to attend fundraising and designated School and Institute Fellows' events. In return Fellows will have full access to the Institute, its facilities and resources, discounted events and training courses. The positions are non-stipendiary. Office space in the IHR is limited but Fellows may be able to have access to facilities in the School of Advanced Study (subject to government restrictions related to COVID-19).

## **DEADLINES**

Complete applications must be received at the Institute of Historical Research no later than **22 April 2022**. Incomplete applications or applications arriving after this date will not be considered.

Interviews will not routinely be held.

## **APPLICATION CONTENTS AND FORMAT**

Hard copy applications will be deemed ineligible. Only applications made using the [IHR's online application system](#) will be considered.

As well as completing the 'Personal Details', 'Education' and 'Referees' sections, applicants should also upload the following three documents:

- A short CV, listing any educational details, publications, research papers and other relevant information, academic or otherwise (maximum of one side of A4, minimum font size 11)
- A statement of research interests (no more than 500 words)
- A statement outlining how the applicant will benefit from the affiliation with the IHR and how they intend to contribute to the life of the IHR (no more than 300 words)

Senior Fellowship applicants **do not** need to upload the thesis statement or the sample of written work which is requested in the 'Upload Section' of the online application form.

**THE DEADLINE DATE FOR THE RECEIPT OF APPLICATIONS WILL BE 22 APRIL 2022.**

## **REFERENCES**

Applicants should supply the names and contact information of two referees. References will not be taken up until an appointment is provisionally made.

## **FINAL REPORT**

A brief, annual narrative report must be submitted to the Institute. This will be due by end of June each year and will be completed on a standardised form. The report should detail the activities undertaken during the previous year of the fellowship, contributions made to the life of the IHR, and future relevant plans. In the final year of your fellowship term, the report will also ask whether you wish to apply for renewal of the fellowship for a further year. At end

of June each year, we will also require some basic figures reflecting research and engagement activity during the year, which are sent to the School of Advanced Study for use in their reporting of statistics.

### **SELECTION POLICIES**

Applications will be considered and decided by a panel, chaired by the IHR's Advisory Council Chair, and including the IHR Director, as well as two other members of the Advisory Council. The committee will assess the quality of applications with reference to the following criteria:

- The academic record or other relevant activity of the candidate as exhibited by their application;
- the importance of the proposed research to the applicant's field and its prospects for publication in a leading academic journal or as a monograph, where relevant;
- the significance and impact of the public promotion of History in which the candidate is involved, where relevant;
- the candidate's likely contribution to the life of the IHR.

### **THE SCHOOL OF ADVANCED STUDY**
